

The Streets of Caversham

Strategic Planning is often a dry and bewildering area but we are seeing its impact in many ways. It is an obvious area for communities to work together to pool resources and share local knowledge and expertise.

The involvement of CADRA and other associations has been critical in achieving protection for sites in Caversham. Subject to the final stages of the process, this will be effective to 2026 (see page 3). Maps showing the sites will be available to view at the CADRA AGM.

The Development Framework for the Caversham Lock Area was central to decisions made for that area. The campaign to restore the Kings Meadow Pool is making progress

with seeking funding. We are now seeing the start of a Development Framework for the area around the station reaching as far north as the river. See page 3 inside.



In 1999, Bracknell Wokingham and Reading formed the **re3** partnership for the management and disposal of waste with a shared strategy.

The kerbside collection remains part of Reading Council's Street Care Services along with street cleansing, public toilets, verge maintenance, and trees, as well as enforcing aspects of Environmental law. This links with the work of the police and the newly updated Neighbourhood Action Groups. See page 2 inside.

Following a brief AGM, we look forward to hearing more about the work of **re3** and Street Care services and their plans for the future.

The state of roads and pavements during the cold weather brought a host of comments. St Peter's Hill was closed for the first time in over 30 years and the icy pavements in Caversham Centre were a common concern. The widely anticipated carol singing event in Caversham Court gardens coincided with the first major fall of snow and the enormous disruption that night.

Though sadly the event had to be cancelled, the gardens looked magnificent in the snow which was followed by a magnificent display of snowdrops under the old yew tree. Do look out for the other spring bulbs as they come into season.

And finally, from the review of the 2009 Reading Festival with serious problems on the last night, it is clear any similar incidents at the 2010 festival will be dealt with severely.

Transport

TIF - Transport Innovation Fund

The £300m+ TIF bid to government from Reading and adjacent authorities is apparently 'on the Ministers desk'.

TIF funding was tied to some form of congestion charging but this aspect has recently been dropped and TIF is to be superseded by UCF (Urban Challenge Fund). This may be opportune for Reading with a bid waiting which may comply with both criteria, though with government spending cuts looming we'd better not be too hopeful.

Funding could bring a whole range of measures: buses, walking, cycling and maybe (last on list) a third Thames Bridge. The proposals are roughly in line with the current Local Transport Plan.

Local Transport Plan

The existing Reading Local Transport Plan LTP(2) will expire in 2011 and a new TLP(3) 2011-2014 plan needs to be produced for government funding assessments. Reading has just started on a consultation process so look out for opportunities to comment. CADRA will be scrutinising proposals and responding where appropriate. The timescale will give a chance to consult with members and to feed back in the next Newsletter.

Reading Station

The station and major developments to the south appear to have received most of the necessary approvals but finding details of these proposals is not easy. Some artists impressions and plans are visible in a shop window by the bus-stops at Western tower and also by trawling the internet. Details are elusive, particularly for the transport interchange, including buses, taxis and drop-off/pick-up. For Caversham the intention is that ultimately these will be to the north of the station with access probably via Vastern Road. A low level (subway) path linking north to south should make access to the station and town-centre easier than at present (remember twenty years ago?). CADRA is trying to obtain more details.

Reading's Transport User Forum has a CADRA representative which allows us to comment and hear other views. At the last meeting there was widespread concern about the interchange proposals at the station which may not reap the benefits of the £500m station investment.

Neighbourhood Action Groups

Since the introduction of neighbourhood policing, there have been parallel groups for policing and safety issues. For Caversham this has meant the Safer Caversham Forum, a Neighbourhood Action Group for Lower Caversham including Caversham Centre and another for North and West Caversham

Across Reading, it has been proposed that Safer Forums and NAGs should merge to avoid duplication and ensure that all groups have some formal support. The Council proposed that there should be one amalgamated group for all of Caversham. Local associations and Caversham's Inspector Penny MacKenzie raised concerns that it would be impractical for a single group to address detailed problems across such a wide and diverse area. Following their representations, it was agreed that, provided there was demonstration of community involvement, the Council would support two groups for Caversham.

Inspector Mackenzie and the local associations worked together to publicise an open meeting at Highdown School. This was well attended and those present took part in establishing the key priorities for North and West/Upper Caversham. These will

include burglary, road traffic and environmental issues which contribute to crime and cause concern locally. The inaugural meeting of the newly reformed NAG met on 23 March.

An open meeting will also be held in Lower Caversham and key priorities established there to carry forward the excellent work done by the existing NAG.

The NAGs identify the areas which cause problems for local people and try to tackle these issues with the help of the police, local Councillors and Reading Borough Council. RBC will provide logistical and financial support but each group will be chaired by a local resident. The groups do need local support. One way you can help is to ensure that any crime, no matter how minor, is reported to the police.

Overall reported crime in Caversham has significantly reduced over the last twelve months, by around 25%.

A Vision for Caversham

CADRA has been active in helping to reestablish the Caversham Traders Association, now known as the Caversham Retailers Association. This momentum has been enhanced by the helpful assistance of local MP Rob Wilson who recently held a meeting of interested parties. The meeting heard about the successful concepts of the Business Improvement District adopted by Reading and the Town Centre Manager in place in Woodley. These are

longer term possibilities and an obvious starting point for Caversham is to address, with the owners, the state of the precinct pavements and buildings and the issue of unmonitored parking.

Mapledurham Pavilion

The Management Committee is not currently considering any of the options to rebuild/refurbish the Pavilion as they are unaffordable within the current budget. However it remains active and has recently agreed new Terms of Reference with Reading Borough Council who are the Trustees. It has also agreed a new

charging structure for users. Minor repairs and redecorations have been made to the Pavilion and discussions continue with Festival Republic, who run the Reading Festival, on their possible future investment in the Pavilion.

Sites and Detailed Planning Policies

The process of allocating sites for development, change or protection is drawing to an end. The final public consultation closes 2 April and after consideration by the full Council it will go to the Secretary of State for approval.

Working with other local associations, CADRA has secured long term protection for many of the green spaces north of the river and influenced many of the detailed planning policies for dealing with planning applications. It has been a major task and we were complemented in Council for being 'assiduous'. Many thanks to all concerned..

Full details and maps can be found on www.reading.gov.uk/ consultations/2010consultations. Some of the development sites in Reading remain controversial. North of the river, the only site earmarked for development is at Lowfield Road for 21 to 34 houses with the proviso to take account of the potential for contaminated land and not be detrimental to important landscape nearby.

A significant change is the provision for much needed affordable housing. Developments of five or more units will be required to provide a percentage of affordable housing within the scheme. This percentage will increase for larger schemes. Schemes for less than five units will make a financial contribution towards affordable housing elsewhere. The site of the former Caversham Laundry on George Street was also considered. Following revision of the flood map, this is now not suitable for housing. While CADRA have long opposed over development of this important site, we have raised concerns that it could now suffer planning blight.



Another far reaching strategic decision will be the Development Framework for the area around the station. This will be visible from Caversham and comes as far north as the river. There are some exciting ideas included. The framework anticipates the areas coming available for development and includes guidance on heights and massing for individual developments. It also covers civic open spaces, public art and green and pedestrian links. This is a shorter document and worth a look at www.reading.gov.uk/saf. The consultation closes 2 April 2010.

All of these documents are also available at Planning Reception at the Civic Centre and currently in public libraries.

Tree Strategy

RBC has published a draft tree strategy for Reading and would like to receive comments by 2 April 2010. The strategy recognises the importance of trees and sets out a number of policies and priorities for protecting, managing and enhancing Reading's tree cover. These include identifying the locations for prioritising the protection and planting of trees and replacement of trees that have been removed. An overall target of an increase of 10% of the tree canopy area in

the Borough is proposed. You can view a copy of the draft tree strategy at the Civic Centre, public libraries or online at www.reading.gov.uk/treestrategy.

Fresh Food

On 3 and 4 June during half term, the Oracle will be presenting its Fresh Food Festival on the Riverside with celebrity chef James Martin, hosted by Ready Steady Cook Lesley Waters, as well as a traditional farmers market, live jazz, exotic cocktails and wine tasting.

On 5 and 6 June Reading Abbot's Fair is a new two-day festival 'fusing the traditional, rural aspects of Reading's food heritage with its modern, urban heart.' Live music and food stalls run by local restaurants will add to the festivities.
