Changes Imposed at Safer Caversham Forum

In his final article for CADRA NEWS (March 2003), retiring Chairman Bruce Manning lamented the summary termination by Reading Borough Council of the North Area Consultative Committee, the only general consultation vehicle available to residents. All the district's residents' groups expressed fears that the Council might attempt to fill the gap it had created by stretching the scope of the Safer Caversham Forum (SCF) to suit a new agenda. Alas, this has now happened.

Six years ago the SCF was established by the council, in partnership with the police, to engage the local community in the fight against crime and the fear of crime. Representatives from seven residents' groups met council officers, the police and councillors from each of the area's three wards every five weeks. Debates were full and uninhibited. Lav members and the professionals were able to understand each others' problems and to seek solutions, help and advice from each other. The frequency of meetings and the fact that the Chairman was chosen by the lay members from among their own number meant that they had a real involvement. This sustained their enthusiasm and maintained their high attendance levels, which, in turn, led them to initiate, manage and staff three major campaigns that had a measurable impact on crime figures, and to develop within the Forum an organisational structure which the council tried to adopt for use in other parts of the Borough. Unfortunately for the residents of Caversham and Emmer Green, the success of their Forum was not replicated across the Borough. The council has, therefore, decided that the SCF must be made to conform.

For the first time in six years, written Terms of Reference have been imposed. An undefined concept of "community safety" has been added to crime and the fear of crime as subject matter for the Forum. Under the new concept, the SCF will consider major planning applications, traffic issues, social matters and other subjects previously taken to the axed North Area Consultative Committee. The Forum's extended scope will be covered at meetings illogically reduced from ten to four per year. Between the quarterly meetings, a special subgroup will meet, "as necessary" and under the chairmanship of staff from the council's community

unit, to examine particular problems and report back to the Forum. The subgroup will consist mainly of relevant professionals and councillors who are happy to meet during normal daytime office hours. Lay Forum members and relevant local residents will be invited but, obviously, their ability to attend depends on their employment situation. Although the SCF will be permitted to continue its practice of appointing its Chairman from among the residents' groups, the Vice-chairman will be a councillor appointed from the ruling group. No credible explanation for politicising this appointment has been given. There are no present plans to give ward councillors from Thames or Peppard a turn, despite the fact that the ruling party is the minority party this side of the Thames.

Along with other residents' groups, CADRA has protested loudly. Whether or not the changes have merit, residents' representatives feel frustrated and saddened that, yet again, decisions have been foisted upon them without warning and without consultation. We try very hard to co-operate with our council and wonder why it seems determined to reject us.

Planning Update

Couthern Electricity has entered Oa revised application for outline approval for 180 homes on their redundant depot in Amersham Road. Notwithstanding the generous contribution the company is prepared to make towards the development of local schools and roads, CADRA is opposing the proposal. We maintain that the social history and layout of the present Amersham Road estates make it imperative that improvements to the infrastructure are carried out before such another large development is squeezed into the area. In this the Association is supporting the local residents' associations as well as individual CADRA members.

Kingsoak Homes have won their appeal against a decision to refuse an application to build 96 homes behind Henley Road and Lower Henley Road. As expected, the Council's Licensing Committee rejected the application for a Public Entertainment Licence in respect of 2 Bridge Street, Caversham. Without such a licence, the proposed nightclub cannot operate. Predictably, the applicant has lodged an appeal against the decision. It is anticipated that Magistrates will hear the appeal in the latter part of this year. CADRA will attend the hearing and give evidence in support of the original decision.

In response to a plea for help in

Lin has ferreted with enthusiasm among the planning papers held at Civic Centre, and her efforts are greatly appreciated. Members will also be interested to know that Jennifer Millest was elected to the CADRA committee at the last AGM. Jennifer has been the planning officer for the Lower Caversham Community Association for some time and continues in that post. It is good to have her considerable experience in the planning field available to augment the knowledge of CADRA's home-grown planning representative.

Neighbourhood Watch Report

In the last issue of CADRA NEWS we were able to supply reported crime figures for the district down to 31st December 2002. It was hoped to bring you a similar report for the period 1st January 2003 to 30th June 2003 in this issue. Unfortunately this is not possible. However, we are able to offer information covering the months of April and May 2003 with the comparative figures for April and May 2002 in brackets.

The total of all reported crime in Caversham Ward was 224 (275). Within the total, house burglaries accounted for 22 (18) reports and thefts of vehicles accounted for 5 (40). Criminal damage to vehicles resulted in 10 (10) reports. For Thames Ward the total of all crimes reported was 101 (117). House burglaries made up 16 (22), thefts of vehicles 8 (3) and criminal damage to vehicles 7 (10). Peppard Ward had 122 (112) reported crimes, which included house burglaries 13 (9), thefts of vehicles 8

(15) and criminal damage to vehicles 13 (3). Drawing meaningful conclusions from these figures is difficult because of a change in which certain crimes are now recorded and the fact that one category, for example criminal damage to vehicles, could have arisen from the activities of just one individual on the rampage in a single

When the new police office is opened in Church House, Prospect Street, having been relocated from Emmer Green, the sector police team available to use it will again have been depleted after barely twelve months of being up to strength. The sector inspector has been moved to another post in Reading, the sector sergeant Dave Griffiths has been promoted to acting inspector and necessarily allocates most of his time to his West Reading responsibilities. PCs Chris Manetta (Emmer Green and Caversham Park) and Peter Stratton (Caversham Heights) stay in post but, between them, also cover Central and Lower Caversham following the temporary transfer of PC (acting sergeant) Rob Pitman to Loddon Valley.

The opening of the Church House office has proved to be a highly moveable feast. The latest target time is It is expected that mid-August. Thames Valley Chief Constable Peter Neyroud will perform the ceremony, with the Police Chaplain and the Rector of Caversham attending.

Sad to say the co-ordinators' meetings planned for April (see the March CADRA NEWS) did not take place. Liz Herbert has not yet been able to reschedule them. Liz is currently hunting for a new Sector Coordinator, as Derek Bartlett has found it necessary to surrender that post on being appointed CADRA's Chairman. He says that there is nothing incompatible in holding both jobs, it is simply a case of trying to allocate a scarce resource, time, among a number of competing demands.

CADRA Profile - Mrs Molly Casey

As a way of making committee members better known to all of us, CADRA NEWS will print a series of personality profiles. The subject of the first is **Molly Casey**, whose name for many is synonymous with the Association itself.

Molly was born in Reading but spent her childhood near Oxford. As an adult, she returned to the Borough in 1953 when she made her home in Caversham. A teacher by profession, Molly held appointments in a number of Reading schools until her retirement in 1987. She did not wait until retirement before using her talents in the service of the community. Molly had already become a well-known activist through her opposition to a proposal to drive a link road through the heart of Caversham to serve a third Thames Bridge. She was also in her 23rd year as the columnist "Watchdog" for "Caversham Bridge", a role she was destined to fill for a further 14 years. Last year, she served on the organising committee for the first ever Caversham Festival. Nowadays she remains an active member of the Civic Society as well as continuing her involvement with CADRA.

Molly's CADRA career began in 1967 when she and others founded the Association, which grew out of the ad hoc committee

set up to oppose the proposed siting of the link road to the third Thames bridge. Always a member of the committee, she also served as the Secretary for very many years, bringing to that post a natural authority, clarity of thought and determination, which endowed CADRA with a respect and influence that has endured to this day. Although she laid down the burden of executive office in CADRA when she accepted the post of Honorary Life President, she has regularly exercised her constitutional right to be present at committee meetings where her experience and knowledge is frequently sought, freely given and gratefully accepted.

For Molly, CADRA's greatest achievement so far has been the part it has played through the years to ensure that Caversham has retained its own recognisable identity, rather than becoming known only as a suburb of Reading. Her greatest regret is that CADRA and its allies, after a long and punishing fight, were not able to prevent the loss of Bugs Bottom to developers. Looking to the future, Molly hopes for such a great increase in CADRA membership that the Association is generally acknowledged as able to represent the views of the majority of the residents of Caversham and the surrounding districts.
