

# **School Places**

In Reading and in Caversham, there are too many children, chasing too few school places. Since 2005, increasing numbers of Reading Borough Council Primary and Secondary schools have been oversubscribed and a growing number of parents have been unable to gain places for their children at the Primary and Secondary schools of their choice. A cross-party Board of Councillors, Head Teachers, Representatives of Faith Schools and an Independent Chair was established in 2008 to identify options for the future.

Demand for primary school places is expected to rise until 2012 when it will

level off. This will translate into increased demand for secondary schools places. Currently, 40% of Reading's secondary school age pupils attend schools outside the Borough. Availability will reduce following developments to the East, South and West of Reading.



More locally, 48 children living within the Highdown designated area were not offered a place in September 2008. For primary schooling, earlier estimates for the 2009 entry into reception classes in north Reading showed a deficit of between 29 and 45 places.

Across Reading, there is a need to provide five additional forms of entry in primary schools and five to six forms of entry in secondary schools, primarily in the south and east of the town. As well creating places for primary and secondary school children, a thorough review of designated areas is considered necessary.

Options to increase places in Caversham, include the expansion of Highdown School by 40 places in Year 7 (a whole school expansion of 200 children) and the relocation or provision of a new primary school on the Highdown site. All proposals to expand schools will be subject to statutory consultation and the availability of capital funding.

Following the public consultation and public meetings, Cabinet will meet in November to consider recommendations on options to be taken forward. You can hear about the background and the next steps at the CADRA Open Meeting when two senior managers from the Education Department will give a presentation of interest to the wider community and to parents of both primary and secondary school age. We look forward to seeing you. Friends and neighbours are very welcome and can sign up as members on the night.

# Planning More School Places

### **Reading Station**

The recent exhibitions showed artists' impressions of the new proposals and representatives from Network Rail and Reading's traffic consultants answer were there to answer questions.

The station itself will include a new building at the front to the west, replacing the single story section and encroaching into the taxi rank area. Station access on the north side will be improved with a new entrance and full junction by the present Royal Mail entrance.

The road to the west will be lowered to subway level with access to platforms that way and escalators to higher levels.

Through traffic will be stopped, including buses, taxis, cycles and emergency services. Buses and other traffic will be re-routed via Friar Street and Station Road, which will become two-way. Bus stops will be relocated to the Station Road area and the north side of the station. Taxis will be relocated to three different areas: Station Road, Tudor Road and Vastern Road.

A longer term proposal is to remove the dual carriageway and build out the station/car park over part of Vastern Road.

CADRA welcomes the improvements but has concerns over:

- the impact on bus services and the loss of the main terminus
- taxi ranking in three separate areas
- drop-off and pick-up points
- limited provision for cyclists
- the potential impact on town centre congestion

Although the exhibitions were billed as a consultation exercise, it was disappointing that there was no feedback form or system and the representatives did not take notes.

The Planning Committee have agreed in principle that permission should be granted, subject to resolution of issues with English Heritage on the demolition of the listed building at the west of the original entrance. Permission for the Station Hill plan is subject to permission for the station entrance scheme.

#### Safer Caversham

Neighbourhood Action Groups (NAG's) aim to give local residents structured access to local police to discuss local issues and concerns on crime and antisocial behaviour. They are voluntary organisations made up of police, local councillors and local residents. There is strong support from the police and local councillors but organising and running the NAG is down to local residents. North of the river, the Lower Caversham NAG is well run with a secretary. chairman, treasurer, monthly meetings and documented minutes. Sadly, the Upper Caversham NAG has disbanded due to lack of support. The local police and councillors are keen to re-start the

Upper Caversham NAG and a survey has been circulated to canvas local views. Following the survey results, a public meeting will be held to discuss restarting the NAG. These organisations are important but cannot work without the support of local residents.

The Safer Caversham Forum (SCF) meets quarterly on broader issues for Caversham's safety and its environment. It has administrative support from RBC.

Burglaries have increased across Caversham, often via unlocked or open gates, doors and ground floor windows. Many involve garages or sheds with valuable items and tools taken to get into the house. Try not to be the soft target in your neighbourhood!

RBC Streetcare and Thames Valley Police have a programme of Environmental Visual Audits across Caversham which local residents are welcome to join to raise concerns and give local knowledge. A dedicated Environmental Liaison Officer is now in post for all areas north of the river. Meeting times and dates will be agreed with the NAG groups.

The Environmental Agency is holding a drop in session on 'Flood Planning' Monday 19 October 5-9pm at Amersham Road Community Centre.

## **Mapledurham Pavilion**

Unfortunately all of the current options being considered by the Management Committee to rebuild/refurbish the Pavilion are unaffordable within the current budget. Therefore, the Cabinet of Reading Borough Council, who are the Trustees for the playing fields and pavilion, have been advised that further

consideration of the matter has been suspended for twelve months at which time the situation can be reassessed. CADRA continues to work with interested parties to try and find an acceptable solution to the problem.

### **Reading Festival**

Festival Republic applied for a variation in the license and were granted an increase in permitted sound levels offsite, increased 'early bird' tickets permitting access on Wednesday ahead of the main entry and an increase of 10,000 tickets phased over three years. CADRA and WADRA worked closely with the organisers and Council Licensing Officers and achieved useful concessions to mitigate the impact on local people.

Complaints and comments received are an important for planning for subsequent festivals - contact Licensing (rbclicensing@yahoo.co.uk). CADRA and WADRA meet the festival organisers and Licensing Team in early December and would welcome comments.

You may have seen signs for free plums at Cross Lanes Farm. This followed discussion on how to overcome the loss of trade during the festival in previous

years. Thanks are due to Festival Republic for a successful initiative.

At the Green City and Open Spaces Forum on 'Towards a Low Carbon Reading' different speakers outlined a dual strategy to reduce the carbon footprint in the Council's own premises and at the same time work in partnership with both public and private organisations to make progress across Reading.

#### **Caversham Lock Area**

On 28 September 2009 the Council's Cabinet again considered the two competing proposals. The commercial bid for a hotel and bars had additional terms which were not acceptable to the Council including a 250 year lease. CADRA opposed this as it may have prejudiced the long term future of this sensitive area.

The Cabinet agreed to offer a period of two years exclusivity to

the Kings Meadow Campaign, during which time they will need to submit a planning application and ensure a firm financial footing. No public funds will be available to them.

The Cabinet thanked CADRA for their detailed work and balanced perspective. We now await the actions of the Environment Agency to dispose of the Lock Island.

### **Planning**

South Oxfordshire District Council is finalising its housing strategy to 2026. The list of development sites submitted to them will go to consultation this autumn. Some are on or near the Caversham border. CADRA is now routinely receiving details of planning applications in South Oxfordshire and will review those near Caversham.

External proposals for another twelve

Reading sites have been received and will shortly go to consultation. These include part of Reading Golf Club and Caversham Telephone Exchange. See details on CADRA website. Full proposals on Site Allocations will be put to the full Council in January, followed by a 6 week consultation before submission to the Secretary of State.

Applications on Upper Warren Avenue,

South View Avenue and St Peter's Avenue bordering on Mapledurham Playing Fields have produced concerted local action with support from CADRA.

The Station Hill plans have been approved subject to permission for the Station Entrance scheme, design codes and a Section 106 agreement.

## **Reading Buses**

As a result of serious financial difficulties, there have sadly been a number of reductions in service - particularly the school services which have not covered their operating costs. The excellent 922 service connecting children in Caversham with schools in the area around the hospital, has now been replaced with the 981 which leaves earlier in the morning and will depart from the schools before some schools finish for the day. Frequencies on the 22 service have also been reduced.

There are various ways of reducing the cost of bus travel. Smart Cards reducing the cost per ticket, can be bought from Broad St Mall or Great Knolly's Street and will soon be available online. Cards can be topped up on the bus or at a "Paypoint"

retailer. In Caversham, these include the Corner Store Gosbrook Road, and General Stores Nire Rd.

If you are travelling in a group of up to four, with any combination of adults or children, you can buy a group 'busabout' for £6.50, giving unlimited travel on that day. This is a saving even for two adults. A North Zone 7 day travel card from Caversham to Reading Centre costs £10 or £17 for all Reading zones.

If the bus service is not sufficient for you to manage without a car, you may be interested in the possibility of a car club in your area. Contact 'Commonwheels' at www.commonwheels.org.uk.
