The Borough of Reading (Civil Enforcement Area) (Waiting Restrictions Review 2018 A) Order 2018 Thames Ward

Reading Borough Council under Sections 1(1), 2(1) to 3, 4(2), and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 as amended and under the provisions of Part 6 of the Traffic Management Act 2004 intends to make an Order the effects of which are: To introduce, remove or amend existing waiting restrictions and parking places either in the interests of safety or in response to demand. This has necessitated changing or revising existing Traffic Orders.

Peppard Road: Introduce 'no waiting at any time' around its junction with Cedar Wood Crescent.

Dovedale Close, western end, north side: Introduce 'no waiting at any time' from its western end to a point 8m east of that point.

Dovedale Close, western end, south side: Introduce 'no waiting at any time' from its western end to a point 5m east of that point.

Woodcote Road: Introduce 'no waiting at any time' around its junction with Harrogate Road.

St Peters Avenue, southwest side: Introduce 'no waiting at any time' from its junction with Wychcotes to a point 10m northwest of that junction.

Wychcotes, both sides: Introduce 'no waiting at any time' from its junction with St Peter's Avenue to a point 18m southwest of that junction.
